### Description

Code of Ethics All members of BID have to respect the Rules and Regulations of Professional PI of Germany (Berufsordnung für Detektive in Deutschland) and the "BID Code of Ethics".

### Association

#### Membership Criteria:

Based on the Statutes of the BID, the following criteria for membership have to be met:

- Minimum age of 24 years
- Well-ordered personal and economic conditions
- No restrictions in full legal competence
- No previous convictions concluding to inferior cast of mind or which may raise questions about personal reliability
- Minimum practice of two years as independent private investigator
- Proof of professional qualification  
That could be:
  - Participation at BID-Continuing-Professional-Development-Programme, or
  - Successful qualification and achieving the required credits of professional skills examination for private investigators of the ZAD, ZENTRALSTELLE FÜR DIE AUSBILDUNG IM DETEKTIVGEWERBE (central department of education for private investigator industry).
  - Present qualification for many years in law enforcement offices.
  - (An admission interview is mandatory in all cases.)

BID-Continuing Professional Development Programme started 2008 and it planned until 2020.

BID Continuing Professional Development Programme is certified by IKD in April 2016.
