In 2022 APDPE resumed its activities after having to suspend its annual conference and other meetings because Covid-19



restrictions. The Conference and AGM took place in March 2022 in Madrid, with an outstanding attendance. Training seminars included legal updates, investigations on home violence cases, preventive investigations, investigation of public crimes by PD according to the Supreme Court decisions, the verification of the legitimate interest of clients and others. The conference was attended by the chief of Private Security of National Police and Guardia Civil, among other authorities and foreign detectives.

During 2020 and 2021, APDPE continued with its "Encuentros" (seminars) through on-line platforms. In 2022 the association took profit of this experience and did several on-line conferences.
