Comments on Association Activities, if any:

PSLD constantly supervises the activity of all companies in the detective sector. Complaints about all detectives' actions are also monitored and recorded, and injured people are instructed on how to proceed in a given situation. The president of PSLD acts as an expert in court cases, resolving disputes arising between clients and detective companies. Training is constantly organized for PSLD members to improve their skills. Next year, the association's authorities are scheduled to meet at the IKD meeting.

From January 2014, detectives professionalism will no longer be checked. As a result of the deregulation of the Detective Services Act, the state licensing examination was abolished, and the training itself does not guarantee adequate knowledge of the detective.

Comments on Regulation, if any:

Regulations have resulted in a significant increase in companies providing detective services. Unfortunately, it can be assumed that more than half of them do not know the law and act without respect for ethics, often performing illegal activities.
