In 2024, LIDEPPE took the following steps:

We asked the Public Security Police to include in the annual Private Security report a recommendation on the need to regulate the private detective profession in Portugal. The Public Security Police have been diligent in considering this issue.

LIDEPPE changed its Code of Ethics and adopted the Code of Professional Conduct created by Kitty Hailey. This decision was based on two fundamental points. The first is that we feel that this "Code of Professional Conduct" is more than just a formulation of rules, as it goes into more detail on each of them, presenting a complete structure, providing essential arguments for its application. Secondly, because we realize that this Code of Professional Conduct is flexible in being applied with or without specific laws for the exercise of professional activity and can be adapted to both situations and their eventual changes.

LIDEPPE has exchanged information with Portuguese government bodies and is currently working on a request for an assessment of the private detective profession, particularly with regard to the risks that could impact on the rights, freedoms and guarantees of citizens, both those who work as private detectives and those who are investigated in the course of their work.
